**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#111 is a 2-1/2 story, detached brick house, three bays wide and approximately four bays in depth with a two story, brick "L" shaped wing, two bays wide and three deep with a side balcony. All brickwork is in common bond. The front entrance occupies the left bay with double doors and two large windows to the right. The first floor is fronted by a wide covered porch with turned pillars decorated by bands of dentils and with very ornate, cut and scrolled brackets. A second story bay window is centered in the right side bays and adorned by fluted pilasters and panels. This is crowned by a steep-sloped pedimented dormer window with vertical dentil trim. Front and side windows are of 1/1 sash and the wing and side attic windows are of 2/2 sash, all with two row header, segmental brick arches. The front section has a broad, moderate-slope, slate "A" frame roof with small enclosed chimneys rising at each side. The wing has a shed roof. The front cornice and wooden frieze are trimmed with a narrow band of dentils. The house rests on a low field-stone foundation and sets back from the pavement.
