DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Nos. 112 & 114 N. Market Street occupy this three story building. It has three bays on its facade and is built of tan brick laid in common running bond with the trim a tan stone. The roof is flat.

There is a base across the building at sidewalk level. This has a basement window under the center bay and a set of limestone steps in each side bay leading to the two entrances. The south entrance (No. 112) is to the upstairs of the building; No. 114 opens into the first floor. On the corners are square, rusticated stone columns. Between the bays are round columns of the Tuscan order. All the columns have attic bases and Tuscan capitals. There is a large undivided window in the center bay, this and the entrances have metal frames and transoms. Over the capitals of the columns is a simple stone entablature. Its cornice has a row of dentils and is supported at either end on brackets mounted on the frieze.

The building's corners at the second and third story levels have stone quoins set flush with the brickwork. The windows on the second floor are wood double hung with 1/1 sash. They have stone jambs and lintels with consoles for key blocks. Under each window are stone balusters supporting a railing which extends across the entire front. The third floor windows are similar to these but there is no railing under them. The sills are stone and have small supports at either end.

Over the third story windows is the entablature. This is composed of a small architrave, a plain frieze and a cornice with heavy modillions and fluting on its topmost piece. The cornice is supported by consoles at both ends. These have garlands of foliage wrapped around their top scrolls and their lower parts are ornaments with masks on them.

Above the entablature there is a parapet. This has rusticated stone breaks on the corners. On the front of the parapet is a fluting motif and in the center a large stone ornament fashioned of a shield surrounded by olive branches. The parapet is topped with a stone cap.
