DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#113 is a detached, two story, frame house with the main section being approximately four bays wide and two in depth and a centered frame front section being two bays square with a three story, one bay square tower to the right (E) side and a one story, partly enclosed porch centered on the rear. The house is sheathed with narrow, colonial-style clapboarding. A period door opens into the right side tower section. This tower is capped by a steep slope, "A" frame roof of slate with bargeboard trim and turned finial-pendants on the front and rear. This tower is also decorated by large lozenges between the second and third story windows and by half timbered decor above. The first floor of the front section contains a centered shallow bay of four windows trimmed with scallops and panels. All house windows are of 1/1 sash framed with flat architrave and side windows are protected by ornamental pent roofs. Both the front and main sections have steep slope, slate "A" frame roofs with overhanging gables trimmed with bargeboards and turned finial-pendants as on the tower. A double flue chimney rises from the center of both sections. This house rests on a low fieldstone foundation with brick cellar walls and sets back from the pavement.
