DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, very wide, brick pair of 2-1/2 story houses, four large bays wide with a centered brick pediment and two large bays in depth. They share a "T" shaped, 2-1/2 story brick wing, two bays in depth and three bays wide with side balconies having Victorian turned banisters and are ended by a full-width end section, 1/2 bay in depth and of stuccoed brick. All brickwork is in unpainted common bond. Front entrances occupy the inner bays with glass/panel doors and three pane, segmental arched overlights. The first floor is protected by covered porches supported by square brick pillars. All front windows are of 1/1 sash with two row header brick arches, as above the front doors. Wing windows are a combination of 1/1 and 6/6 sash with wood lintels and sills. The attics are lighted by pairs of four pane windows on the left and six panes on the right with small, 1/1 sash windows in the front pediment. Both the front and wing sections have moderate-slope, "A" frame roofs of asphalt shingles with overhanging rooflines. A double flue enclosed chimney rises from each gable. The building rests on a low fieldstone foundation and sets back from the front pavement.
