DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story, frame pair of houses, four bays wide and three in depth with a two story, full-width wing, two bays in depth with rear galleries. The building is mostly sheathed in asphalt shingles except for the front and left side of #120 which now has asbestos siding. Period doors and transoms occupy the inner bays and the first floor is fronted by a covered porch with Doric pillars. All house windows are of 1/1 sash. The front section has a moderate slope, "A" frame roof covered by asphalt shingles on #118 and metal on #120, as is the wing. The building rests on a low, concrete block foundation and sets back from the pavement. A double flue chimney rises from the center of the front section.
