DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and three in depth with a two story, frame, full-width wing, two bays deep with a rear balcony. The building is now sheathed with brick patterned asphalt shingles. Period doors and transoms occupy the inner bays and the first floor is fronted by a covered porch with Doric pillars. All house windows are of 1/1 sash. The front section has a moderate slope, "A" frame roof, and the wing has a low "A" frame roof, both of metal. A double flue chimney rises from the center of the front slope. The houses rest on a low concrete block foundation and set back from the street.
