DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story pair of brick houses, four bays wide and three in depth with a two story, brick, full-width wing, two bays in depth with a rear gallery. All brickwork is in unpainted common bond. Period doors and transoms occupy the outer bays and the first floor is fronted by a covered porch with Doric pillars. All house windows are of 1/1 sash and headed by two row brick header, segmental arches with the infills of the front and left side of the first floor decorated by incised scrolls. The attics are lighted by two, four pane windows in each gable which also have brick segmental arches. The front section has a moderate slope, "A" frame roof which overhangs the front, and the wing has a low slope "A" frame, both being of metal. Double flue enclosed chimneys rise at each end. The building rests on a low fieldstone foundation and sets back from the pavement.
