DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and two in depth with #200 having a full-width, two story, frame wing, two bays deep with side galleries. The building is sheathed with asbestos siding. Front entrances occupy the inner bays with period doors and #200 retains a three pane overlight. The first floor is fronted by a covered porch with turned pillars. Front windows are of 2/2 sash, the sides have 2/2 sash, and the wing has a combination of 6/6 and 1/1 sash. The attics are lighted by a small, four pane window in each gable. The front section has a moderate slope, "A" frame roof joined on the rear slope by the shed roof of the wing, and both are of metal. A double flue chimney rises from the center of the front section. The building rests on a low fieldstone foundation.
