**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a small, 2-1/2 story building in the colonial style. It is built of brick laid in a common Flemish bond painted gray. Its roof is a gable sloping back and front and is metal. On the first story the front has been altered recently but in keeping with the style of the building. It contains two bay windows separated by a section of wood paneling. Under the windows is a simple wood entablature. To the north of these windows is the entrance door. This is a nine light door with two panels below. In the jambs of the doorway are hip-raised panels.

On the second story are four double hung windows with 1/1 sash and louvered shutters. These have wood sills. Over these and under the eaves is a simple brick cornice.
