DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story pair of brick houses, four bays wide and four longer bays in depth with enclosed rear galleries. All brickwork is in common bond. Simple front entrances with segmentally arched transoms occupy the outer bays. Front and side windows are all of 1/1 sash with two row brick header segmental arches, and there are no rear windows. The metal roof slopes to the rear and is fronted by a protruding boxed cornice with dentil trim. Long cut brackets divide and end the house lines. The building rests on a low fieldstone foundation and is fronted by a brick pavement.
