DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#224 is a very low, detached, 2-1/2 story frame house, three bays wide and two in depth with a two story, frame "L" shaped wing, approximately two bays square with a side balcony. The front section and wing are covered by clapboarding except for the rear wall of the wing which is protected by rusticated stone-patterned, embossed metal. The front entrance occupies the center bay with a newer door and a low concrete stoop. Front windows are of small, 2/2 sash and wing windows are of 6/6 sash, all with louvered shutters. Small windows light the attic from each gable. The front section has a moderate slope "A" frame roof with small enclosed chimneys rising from each side. The wing has a shed roof and both are of metal. The house rests on a very low field-stone foundation.
