DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#226 is a detached, 2-1/2 story frame house and wing now sheathed with brick-patterned asphalt shingles. It is three bays wide and two in depth with a two story, frame "L" shaped wing, two bays square with a side balcony. The simple front entrance occupies the center bay with a newer door and two pane overlight. This is approached by a covered front porch. All house windows are of 2/2 sash with louvered shutters. The front section has a moderate slope "A" frame roof with double flue enclosed chimneys at each end. The attic is lighted by two small, four pane windows in the left (E) gable. The wing has a shed roof.

The house rests on a very low foundation. The front cornice is decorated by a band of dentils and closely spaced, narrow-cut brackets on the frieze.
