DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story brick pair of houses, four bays wide and approximately six bays in depth with rear balconies. All brickwork is in common bond and #228 has been recently restored. Simple front entrances occupy the outer bays with segmental arched overlights and #230 retains four panel doors, front and rear. All house windows are of 1/1 sash with two row, segmental arches on the front and wood lintels and sills on the rear. A covered porch supported by turned pillars protects the first floor. The roof slopes to the rear and is decorated on the front by a Victorian "V" shaped cornice with bands of mouldings and discs. Moulded brackets divide and end the houses. This building sets on a rather high fieldstone foundation.
