DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#236 is a 2-1/2 story, detached frame house, three bays wide and two in depth with a two story, frame "L" shaped wing, approximately two bays square with a side balcony. The building is sheathed with asbestos siding. A newer door occupies the center bay and there are 2/2 sash windows on the front and 6/6 sash on the rear area. The front section has a steep sloped, "A" frame roof and the wing, a shed roof, both of metal. Small enclosed chimneys rise from each side. The house rests on a very low fieldstone foundation.
