DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#246 is a 2-1/2 story, frame house, three bays wide and two in depth with a two story, two bay square, frame "L" shaped wing with a side gallery. The entire house is sheathed with asbestos siding. A newer door occupies the center bay. Front and some side windows are of 2/2 sash with the rest being 6/6. The front section has a moderate slope "A" frame roof with small enclosed chimneys rising on each side, and the wing has a shed roof, all of metal. This house rests on a low fieldstone foundation.
