This is a low detached, frame, two story pair of houses, four bays wide and approximately three in depth. It is completely sheathed with asphalt siding. Glass over panel front doors occupy the inner bays, and all house windows are of small, 6/6 sash. The roof slopes to the rear. The building rests on a low fieldstone foundation.
