DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Completely renovated after a fire, very little remains of the original appearance of the old "Penny's" store. The Market Street facade has a metal and glass storefront at the first story and flat metal panels at the second and third. The roof is flat.

An idea of the building's former style can be obtained from the Market Place facade. Here the window openings have been filled in with brick but the arrangement of the wall can still be seen. There were eleven (perhaps twelve - the metal panels return around the building's northwest corner, hiding part of the wall) bays. The windows had stone sills and lintels. Two wider bays had elliptical arch heads. In these bays a panel with a sort of chain decoration is still visible between the second and third story windows.
