DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story, detached frame house, two bays wide and four bays in depth with the gable ends being front to rear. It is said by the owner of #21, Mr. Stevens, that these houses were prefabricated and delivered in sections. The house is covered by clapboarding. A turn-of-the-century door occupies the left (W) bay and is protected by a covered porch with turned pillars across the front. All house windows are of 2/2 sash, most with top moulded lintels. The front gable has a small, four pane window with a peaked decoration centered by a lozenge and roundel. This gable is fronted by a decorative shingle pattern in fishscale and crosshatch designs. The house has a steep slope "A" frame slate roof with square chimneys with deeply corbelled caps rising from the front and rear third of the ridge. It rests on a low fieldstone foundation.
