#25A is a 2-1/2 story frame house, three bays wide and two bays in depth with a two story "L" shaped wing, two bays square with a side balcony. The house is sheathed in clapboarding. A newer door occupies the center door, front windows are of 2/2 sash and wing windows are of 6/6 sash, and there is a four panel kitchen door. The front section has a steep slope "A" frame roof of asphalt shingles with a small chimney rising from each gable, and the wing has a shed roof. The house rests on a low fieldstone foundation.
