DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#29 is a low, detached, 2-1/2 story, frame house, three bays wide and two in depth with a two story, frame "L" shaped wing, two bays in depth and one bay wide with a side balcony. The house is mostly sheathed with clap-boarding but with board and batten siding on one side and rear of the front section. An old, four panel door occupies the left bay. Most house windows are of 2/2 sash with louvered shutters. The attic is lighted by small, four pane windows in each gable. The front section has a moderate slope, "A" frame roof with a small chimney rising from the center of the ridge. The wing has a shed roof, and all are of metal. The house rests on a low fieldstone founda-tion.
