DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is the principal building occupied by Shipley's, Inc. It is very similar to No. 37 N. Market Street except that it is five bays wide instead of the latter's four bays. It must have been the work of the same architect or one of the buildings was a copy of the other.

As mentioned above, it is five bays wide and three stories in height. Each bay has an arch over it with a brick moulding around the arch and down along the jambs of the windows. The arches have stone consoles for keystones. It is built of red brick laid in common running bond and the trim is primarily white stone. Up both corners on the front are brick quoins.

The first story front is a metal and glass storefront and sign plate with the store entrance in the center. To the north of this front is a door to the upper floors.

For sills, the second story windows have a stone course which carries across the entire front. The lintels are similar. The windows are double hung with 1/1 sash. In each bay above the lintel course is a brick panel with a border formed by bricks alternately raised and lowered.

The third story windows have the same sills as those on the floor below. The windows have 1/1 sash but the top sash is in the arch and is fixed.

Above the arches is the cornice. The lowest member is wood painted red to match the brick. It consists of a plain bead and two beads with egg and dart enrichment. There are several course of brick above this and over them a large wood cornice painted white. This has terminating brackets on the corners. These are large consoles with square rosette-like ornaments on their front. This large cornice has a bead moulding for its lowest member above which is a large frieze with garlands of foliage on it. The uppermost part of the whole cornice has console modillions as well as several other mouldings. A flat roof covers the whole building.
