DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A small brick cottage of the late Federal period. That so many of these tiny houses have survived in Frederick is unusual. This one is common bond brick, three bays wide, two bays deep, and has a decidedly medieval appearance with its steeply pitched "A" roof. The window and door bays are not regularly spaced along the front of the house. There is a central door with an overlight and simple wooden moulded cornice. Flanking it are two 2/2 sashes also with simple wooden moulded cornices. There is a one-string brick cornice along the front roof line. There is a chimney enclosed in the east wall of the house. The house sets on a low field-stone foundation.
