"Emerging from 16th Century Merrie England, this hand-crafted Tudor cottage reproduction is accented by a half timbered second story section with pegged joints, scoring marks of the broad axe, and brick panels. It adds a note of antiquity to W. Second Street."

"The diamond-shaped, leaded glass panes and tall mullioned casement windows with small panes bearing haraldic shields cast colorful patterns throughout the rooms."

"Steep gables support slate roofs and a stack of corkscrew chimney pots rises from the center."

Cost of construction by the contractor, Floyd Culler, was \$20,000.00
