DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A log, double house, now covered over with a heavy cement-like stucco, this house is five bays wide, two bays deep, and 1-1/2 stories in height with a very steeply pitched "A" roof. Doors occupy the second bay from each end. Windows fill the middle and end bays. They are 2/2 sash with deeply moulded frames. The only windows on the end walls are at the gable level. The house appears to be built on a high stone foundation. There is a chimney enclosed in the east end wall and in the center of the roof. There is a shed dormer on the roof of new construction.
