DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Once a 2-1/2 story, Georgian style house, it now reflects its modernization of the Victorian period. It is three stories in height and has a flat roof which slopes slightly from front to rear. It is five bays wide and two bays deep. It is Flemish bond brick up to the second story level and common bond above that. All the windows are 6/6 sashes with flat brick arches. There is a central door of the early Victorian period with a hooded cornice supported on brackets. It is reached by three granite steps with a simple wrought-iron rail. There is a quarter-round brick moulded water-table along the front of the house. There is also some evidence that a belt course has been chipped off between the first and second stories. There is a Victorian bracketed cornice along the front roof line.
