**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

A frame double house of the late Federal period, it is six bays long, two bays deep and 2-1/2 stories in height with a moderately pitched "A" roof. The house sits on a fieldstone foundation. The two central bays are occupied by overlights. The first story windows are 2/2 sash, those on the second story being 6/6. All have wide pegged frames. There is a chimney in the center of the roof and at the north end wall.

A very attractive structure with old, irregular clapboards, it has the appearance of an 18th century New England house.
