A 1-1/2 story frame house of the Federal period which in its size and proportions reflects the influence of coastal architecture. It is four bays wide and two bays deep and is a double house. The two central bays are occupied by simple old doors. The windows are 2/2 sash with old moulded frames. The clapboarding is rather wide and old. The house may be log underneath the clapboard siding. There are two 6/6 peaked dormers on the front roof. There is a rather large brick chimney rising from the center of the roof of the house.
