## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building constructed of brick laid in common Flemish bond painted gray. The roof is metal and gabled ~~front to back~~. There is a chimney on either end of the building.

On the first story there is an old storefront. It encompasses a doorway, a storefront, and a restaurant front in that order, moving from south to north. On the ends of the front at this story and between the various parts are narrow wood panels functioning visually somewhat as pilasters. The doorway leads to the upstairs apartments. It has a brownstone stoop with low knee walls and is recessed in an open vestibule. The door itself is wood with a transom over. Both the store and restaurant fronts have transoms over the display windows. Over the entire first floor is a wood cornice supported on brackets. These are located over the wood panels mentioned above with additional brackets over the center of each display window.

At the second floor level are four windows, wood double-hung with 2/2 sash. These have wood sills, shutters and jack arch lintels with brick voussoirs. Over these windows is a simple wood cornice.
