DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This structure is three stories in height and five bays in breadth. It is built of brick in a common running bond painted yellow. The trim is white. Above it hovers a flat roof.

The first floor elevation consists of two recent metal and glass fronts, one for a restaurant and the other a store. At the second and third floor front the windows are double hung with 1/1 sash. They have wood sills and segmented brick arch heads. The head of the window itself is at the springing line of the arch; the arched opening being filled with a small wood panel with a very plain rosette in the center.

Above the third floor windows is the entablature. This has a small wood architrave, a brick frieze, and a wood cornice with two rows of dentils. Between these rows is a member have diamond shaped ornaments on it. The whole entablature is supported on large brackets, one at either end and one in the center. Those on the corners have top pieces on them, carved at the front and with an elliptical disc above.

To the south (left) is a small brick addition housing a door (with transom) to the upstairs.
