## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

There is a vertical joint in the masonry on this building which may indicate two separate buildings or times of building, but the whole presents itself now as a pleasant building. It is 2-1/2 stories high, built of red brick laid in Flemish bond. The trim is wood painted white. Over it is a metal gable roof with the ridge running parallel to the street.

The two storefronts (145 & 149) occupying the first floor, have fronts which are mostly brick. Each has a large glass display window. Between the storefronts is an entrance door to the upstairs apartments. It is a wood door with eight square panels and a transom. The door jamb has raised panels on it. Above the door is a wood lintel with plain rosettes at each end. There is a brick quarter round water-table about two feet off the sidewalk and above each storefront is a small brick cornice.

The second floor has five wood double-hung windows with 6/6 sash. Their sills are wood. Beside them they have louvered wood shutters and above them a wood lintel with rosettes, as on the door below. Above these windows is a small wood cornice.

On the roof are two dormers. These are wood and have segmented arch heads. The window is double hung with 9/6 sash but the top sash is fixed. To either side of the window is very shallow wood pilasters with two flutes supporting a cornice running around the arch.

On the entrance enframement (right side) is a Jewish Mezzuzah, a vial containing verses of Deuteronomy, for daily notice.
