DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#200 is a modern, three story, brick building attached on the left side with the right side being on a corner. It is approximately three bays wide and four in depth with no wing. The front facade and first two bays on the right side have been stuccoed with the first floor being more recently covered by formstone. Exposed side brickwork is in common bond.

The large grocery store on the first floor is lighted by large, plate glass shop windows and entrance. Upper story windows are all of 1/1 sash with the corner having a two story bay window. Only one soldier course brick arch is evident on the right side.

The slightly sloping roof is fronted by a simple moulded cornice "supported" by modillions and the exposed sidewall is stepped down to the rear.

This building probably rests on a fieldstone foundation but stucco conceals the true material.
