DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building occupies a corner site. It is built of dark red brick laid in common Flemish bond. On Market Street it is three stories high and has five bays. The Second Street elevation has one bay on the east (Market Street) corner which is three stories and four bays in a two story section to the west. Roofs on both sections are flat.

On Market Street, the first story is a recessed metal and glass storefront with three display windows and two entrances. The windows have ceramic tile panels below. At the corner is a brick pier. The storefront continues around this corner for one bay. The remaining four bays have small vent windows set high off the floor. These are protected by rod grilles.

All second story windows on both elevations are double hung with 1/1 sash divided by removable muntins into a 6/6 arrangement. The sills are concrete. Above the top sash are wood panels and brick jack arch lintels span the openings. The third story windows are double hung with undivided 1/1 sash. These have no panels over their top sash, but otherwise are identical to those on the second floor.

The Market Street facade has a denticulated cornice, the Second Street elevation does not. A brick parapet with concrete cap rises over the cornice. This steps down to the lower roof on Second Street. There is a chimney on the parapet on Second Street at the high roof.
