DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story structure four bays wide with a flat roof. It is built of brick with wood trim, both painted off-white.

The first story front is a metal and glass storefront. Above this is a wood signplate. On the sides of the storefront are narrow wood panels and above it is a small cornice with a fret band motif.

The four second story windows are double hung with 2/2 sash. They have wood sills and their heads are Roman arches with no elaboration. The third story windows are identical to those below except at the heads. These have a wood panel with carved foliage around the arched opening. To either side of this panel are termini which support the building's architrave. The architrave carries across the facade and breaks out to receive these termini at the windows. The frieze above this remains in one plane for its length, but over the windows has scrollwork grilles. Between windows it is paneled. The cornice runs uninterrupted across the building. It has dentils and modillions and is supported at either end by a bracket.
