**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This building is three stories high and three bays wide. It has a flat roof. Its materials are gray brick laid in common running bond and wood trim painted white.

On the first story is a glass panel door to the left of a wood and glass shop front. This has a door to the right of a display window. On the sides of the shop's front are fluted pilasters carrying brackets, between which spans a denticulated box cornice.

On the second and third stories, the bay to the left of center has a wood bay with three double hung windows with 1/1 sash. Under the windows are panels. Fluted pilasters on the bay's corners carry a cornice above each story. That over the third story has brackets above the pilasters. The remaining two bays have double hung windows with 1/1 sash, wood sills, and plain wood lintels. Those at the third story also have louvered shutters.

Above the third story is the building's entablature, composed of a small wood architrave, a brick frieze and a wood cornice with air vent perforations shaped like Greek crosses on its top member. At the building's corners, brackets support the entablature.
