DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building four bays wide with a flat roof. It is constructed of red brick in common running bond. The trim is wood painted white.

At street level is a low store base. The first story is composed of a wood and glass storefront with the entrance between two display windows, and to the right, an entrance doorway to the upstairs. There is a stone step before each entrance. On either corner of the building and between the storefront and upstairs entrance are wood pilasters supporting a box cornice over the first story.

The windows at the second story are double hung with 16/16 sash. The sills are wood and the heads segmented brick arches. The third floor windows are the same but with 1/1 sash. Above the upper floor's windows is a wood cornice having modillions and air vent perforations in the shape of Greek crosses as its most prominent characteristics. There is a chimney in the south wall.
