DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is four bays in width and three stories in height. It is built of brick painted yellow laid in common Flemish bond. The trim is wood. It is topped with a flat roof.

To the left on the first floor is a doorway to the upstairs. This is a pair of doors with a Roman arch over the opening. In the arch is a transom window. In the center of the first story elevation is a corrugated metal storefront with a metal and glass door centrally located. On the building's far right corner is an opening with an iron gate to an alleyway. Over the gate is a wood grille. On both corners and between the storefront and both doorways are pilasters with consoles at their bases. The pilasters support brackets on which a cornice with stylized modillions rests. Above the cornice is a row of wedge-shaped flutes in the brick.

The second and third floor windows are double hung with 1/1 sash. Under them are wood sills and above them segmented brick arches. At the line of the third story window sills, flutes in the masonry occur between windows, and three brick courses below is another row of flutes at each window.

A form of architrave runs above the third story windows. This is a brick course with wedge-shaped openings the size of header brick. A frieze is made of five courses of header brick, every other brick raised. The cornice is wood with a row of modillions with rosettes between. At each end of the cornice is a bracket. On both side walls are brick chimneys.
