DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building covered with a flat roof. It is built of red brick laid in common running bond.

The first story front is a metal and glass store entrance between two display windows. To the right (North) is a door with a transom to the upstairs apartments. Bordering this doorway and the display windows are rows of header brick. At the top of the first story is a wood denticulated cornice bearing on brackets at the building's corners and between the storefront and upstairs entrance.

The second and third floor fronts are identical, both having three bays of differing types. On the left is a double window unit. The windows are double hung with 1/1 sash and have wood sills and soldier course lintels. In the center bay is a wood bay with three windows on each floor. These have 1/1 sash. Below the windows are wood panels and on the bay's corners are fluted pilasters. Above the third story windows, the bay has a cornice. The farthest bay to the right is similar to that on the left but with a single, rather than a double, window.

Over the third story, a brick pattern extends across the front. This is two courses of headers between which are three courses of stacked brick. Above this pattern is a wood box cornice. There is a brick parapet at the top of the wall.
