### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building constructed of red brick laid in common Flemish bond. Its trim is wood. Covering it is a metal gable roof with a ridge paralleling Market Street.

The first story consists mainly of a metal and glass storefront with the door between two display windows. Over the door is a transom, over the windows are wood panels. To the sides of the storefront are fluted wood panels. At the top of each of these is a console which supports a denticulated cornice above the storefront. To the north (right) of the store's front is a doorway, above which is a transom and segmented arch. Around the opening is a heavy casing moulding.

The second floor front has four double hung windows with 1/1 sash. Each of these has a wood sill, louvered shutters, and a brick jack arch lintel. Above the second story is a wood box cornice and the roof on which are two dormers. These have 6/6 stepped parapet heads. At either end of the ridge is a brick chimney.
