DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building with a flat roof. It is four bays wide but the first bay on the right is narrow and, as shown by a vertical joint in the masonry, was an addition. The structure is built of brick laid in common Flemish bond painted yellow.

The first story is composed of a wood and glass storefront to each side of a centrally located door. The two storefronts are similar; the entrances having transoms and are to the outside of display windows. The doorway in the center is to the upstairs and has a leaded glass transom. To the far right, in the addition, is a door to an alleyway. On the building's corners and between the parts are fluted pilasters supporting consoles on which rests a box cornice extending across the front.

At the second and third stories, the bays are as follows from left to right:
1) A wood bay with three double hung windows with 1/1 sash - these have panels under them and at the bay's corners are fluted pilasters, which, at the third floor, carry brackets supporting a denticulated cornice; 2) At each floor is one double hung window with 1/1 sash having a wood sill and a brick segmented arch at the head. The arch is filled with a wood panel with a rosette; 3) Another three-sided bay, identical to that described above [1]; 4) This bay, in the addition, contains a double hung window with 4/4 sash at both stories - these have wood sills, at the second story, the window has a jack arch lintel, that at the third floor has a segmented arch at its head.

Above the third story windows is the building's entablature consisting of an ornamented wood architrave, a brick frieze, and a cornice with diamond-shaped relief ornaments and dentils. This is supported by brackets at the corners and between the bays.
