DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building five bays wide. It is built of brick laid in common running bond painted red. It has a gable roof with the ridge paralleling Market Street, covered in asphalt shingles.

On the first story in the two bays on the left is a metal and glass restaurant front. The center bay has a doorway with four light transoms over which is a jack arch lintel. To the right of the door are two double hung windows with 1/1 sash, wood sills and ~~jac~~ arch lintels.

On the second floor, the windows are like those below, but with 6/6 sash. The building's cornice consists of a four inch frieze board and a bed moulding. At each end of the roof ridge is a brick chimney.
