DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story building on the corner of N. Market and W. Third Streets. It is built of tan brick laid in common running bond. Covering it is a flat roof.

On Market Street, the elevation is of three bays. The first story is a metal and glass storefront and signplate. This has a door with sidelights and transoms between two display windows. At the second story, the bays have double windows. Each window is double hung with 3/1 sash. Over the windows are two rows of black tiles and above these is a parapet with projections upward at the corners and in the building's center.

On W. Third Street, the first story consists of three large display windows and a garage door far to the right. At the second story are four widely spaced double hung windows with 1/1 sash. The tile pattern and the parapet, with projections between windows, is continued on this elevation.
