DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This 2-1/2 story brick attached building appears to be part of the corner building because of the joint cornice and color of paint, but the roofline is higher and there is a vertical joint in the masonry. It is three bays wide and two bays in depth with no wing or balcony. All brickwork is of painted common bond. The first floor contains a storefront with a central entranceway of two glass doors with a transom and a moulded bar. It is approached by three granite steps. The shopfront is framed by Victorian style fluted and diagonally reeded pilasters topped by a Cavetto shaped moulded cornice. Second floor front windows are of 1/1 sash with wood sills and moulded lintels as on #300. Rear windows are of 6/6 with wood lintels and sills and the doors are paneled with overlights and wood lintels. The building is covered by a moderate slope "A" frame slate roof. The stub of a chimney rises from the left gable. The cornice on the front roofline is a moulded Colonial box type with a beaded moulding in the corner of the soffit which continues across from #300. The rear cornice is obscured by ivy. The building rests on a fairly high foundation.
