DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick attached building, three bays wide and two bays in depth with a one story, full width, shed roof extension to the rear. There is no balcony. Brickwork is of painted common bond. The first floor is fronted by a shop with a central doorway of two glass doors, a high transom, and decorated transom bar. Large paned shop windows lie on either side. The shop is framed by pilasters of small recessed panels which continue across the overhead cornice. This cornice also contains narrow bands of small brackets, a moulded top, and is supported by large fluted consoles on either end. Second floor front windows are of 6/6 pane with flat brick arches. Rear windows are also of 6/6 sash, but with wood lintels and sills. Rear doors are paneled and with overlights. The front section roof is of a moderate slope "A" frame covered with slate shingles on the front but with asphalt shingles on the rear with pattern continuing across #302. A chimney rises from the left gable. There is a four string brick cornice with brick dentils crossing the front roofline. The rear cornice is obscured by ivy. The building rests on a moderately high foundation.
