DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

No. 305

This building is closely related to its righthanded neighbor, No. 309 N. Market Street. It is 2-1/2 stories in height with a gable roof of asphalt shingles in the same plane as that on No. 315. It is built of brick lain in common header bond painted beige.

The first story front is a recent alteration in the Tudor style of half-timber. It contains three connected fixed windows on its right half. Over the first story is a wood shingled awning roof.

The second floor has four double hung windows with 1/1 sash. These have wood sills and soldier course lintels. At the eaves of the roof is a simple cornice. On the roof are three gabled roof dormers with double hung windows with 1/1 sash.

No. 309

This building is very closely related to the building on its left at No. 305. It is 2-1/2 stories high and built of brick laid in common header bond painted beige. Its gable roof lines with that at No. 313 and is metal.

The first story is a continuation of the restaurant front in the building to the left. It is a recent alteration in a half-timber style. The entrance to the restaurant is at the left corner of this building, No. 315. To its right are several fixed windows. Over the first story front extends a wood shingled awning roof and this breaks out into a hif roof over the entrance.

There is a simple cornice at the roof eaves. On the front slope of the roof, far to the left, is a dormer with a flat roof and a window with 1/1 sash. On the right end of the roof ridge are two connected chimneys.
