## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick attached building four bays wide and two bays deep with a three story "L" shaped wing two bays wide and approximately five bays in depth and with a one story addition of about the same period. There are long balconies on the side of the second and third story wings and across the remaining rear bays of the front section.

All brickwork is of common bond with the front facade being of a newer multi-colored pressed brick. This appears to have been rebuilt around the turn of the century and contains 1/1 sash with vertical stretcher flat arches, granite sills, decorations of various formations of a lighter color brick near the top and a parapet, stepped in the center. Original woodwork, such as a richly carved Victorian entablature over the apartment entrance and a dentiled cornice over the shop area may have been reused. Rear area windows are 6/6 sash and 1/1 sash with wood lintels and sills. The front section roof is rather flat and the wing roof is of the low slope metal shed type. There are several small chimneys. The front cornice consists of a three string band of alternately raised bricks. The building rests on a low foundation.
