DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building constructed of brick laid in common header bond painted white. Its gable roof is covered with metal and slopes to and from Market St.

The first story front has a wood and glass storefront to the left of a doorway to the upstairs. The storefront has a recessed door with transom to the left of a display window over which is a leaded glass transom. At the storefront's corners are fluted pilasters supporting brackets on which is an ornamental cornice. The upstairs doorway has double doors with a transom and paneled jambs. In the front of this is a concrete stoop with metal railings.

At the second floor are two double hung windows with 1/1 sash and louvered shutters to the left of a cantilevered three-sided wood bay. The windows in this are double hung with 1/1 sash. At the bay's corners are fluted pilasters and at its top a small cornice.

Above these windows is a plain wood cornice extending across the front. There is a chimney at each end of the ridge.

On the south elevation the building has two windows at the second and attic stories. The windows on the second floor are double hung with 1/1 sash and those at the attic are six light easement windows.
