DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house, detached on the right side, three bays square with a two story "L" shaped wing one bay wide and two bays long with a side balcony and a one story one bay square extension to the rear. All brickwork is of common bond. It has a simple doorway in the left bay with a glass over panels door with an overlight and paneled embrasure and soffit. All front windows are now 1/1 sash with flat brick arches as over the doorway. All rear windows are of 6/6 sash with wood lintels and sills. A 6/6 sash window lights the attic from the right gable. Rear doors are paneled and with overlights. The front section has a moderate slope metal "A" frame roof with wide enclosed chimneys rising from each end wall and has a small four pane dormer on the rear. The wing has a metal shed roof with a chimney on the end. The front and back rooflines have a simple moulded cornice. The building rests on a fairly low fieldstone foundation.
