

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A warehouse complex in three sections, apparently all built at the same time, of brick in common bond and of two stories in height. Section #1 is two bays wide and approximately four bays in depth, headed by a shed roof. All three sections have 6/6 windows with segmental brick header arches of the same design and rooflines are ended by two string brick cornices. Section #2 is five bays wide and three bays in depth. This is headed by a low "A" frame roof now covered with metal. Section #3 is two bays wide and nine bays in depth to the intersection with Section #2. This section is apparently covered by a shed roof. No foundations are visible.
