DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building constructed of rubble masonry painted white. The gable roof is covered with metal and its ridge parallels Market Street.

In the center of the first story is an entrance with a pair of five-light doors. On each side of this is a doublehung window with 1/1 sash. These have wood sills, jack arch lintels, and louvered shutters. Immediately under the sills is a quarter-round watertable, and below each window is a cellar window covered with a metal grille. Above the windows are two courses of raised brick carrying across the front.

At the second story, the front contains three double hung windows with 1/1 sash and wood sills. The middle window is off-center. Over the heads of these windows is a friezeboard and box cornice.

On the roof's front slope are two pediment-head dormers covered in wood shingles. Each dormer contains two windows which have 6/1 sash. On the south end of the roof ridge is a chimney.
