DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#343 is a 2-1/2 story corner brick building attached on the left side. Brickwork is laid in Flemish bond and there are remains of a rounded watertable. This was probably built as a home and later altered for a shop on the first floor.

It is two bays wide and three in depth with a full-width, two story, brick wing which is four bays in depth and a modern brick and block extension to the rear. "S" brace terminals appear on the right wall.

The first floor is lighted by large pane shop windows with a center door. These are headed by transoms of small panes and by a moulded cornice with ornate brackets. Second floor front windows are now of 1/1 sash with 6/6 sash in the wing with wood lintels and sills. Two quaint pairs of 8+8 wooden casement windows are in the first floor street side of the wing. The wing is entered on this street side by glass over panel doors with three pane overlights. The attic is well lighted by wide, double dormer windows of 6/6 panes and shed roofs on the front and rear slopes.

The front section roof is of rather steep slope tied into the roof of #341 on the left side and the plain, boxed cornice also continues across both buildings. The wing has a shed roof fronted by a three string cornice and both are of metal. The street level, fieldstone foundation is barely apparent.
